4. Yuran pendaftaran: sebanyak RM 150.00 (Ringgit seratus lima puluh sahaja) melalui deraf bank, kiriman pos atau kiriman wang yang dibuat atas nama '**Pendaftar Majlis Pergigian Malaysia**'. Wang tunai dan cek persendirian tidak diterima.
5. Kad Pengenalan Malaysia: asal serta satu salinan fotostat.
6. Surat beranak: asal serta satu salinan fotostat.
7. *Taiwan National Licensing Board Examination Certificate*: asal serta satu salinan fotostat.
8. Bukti pengamalan klinikal selama 2 tahun selepas menerima ijazah asas.
9. *Transcript of Grades* bagi 5 tahun
10. Borang 5 di bawah Peraturan-peraturan Pergigian 1976 (Perakuan Perkhidmatan Awam yang Memuaskan dalam Jabatan Pergigian).
11. Kad Pengenalan Malaysia suami/isteri: asal serta satu salinan fotostat.
12. Sijil Perkahwinan: asal serta satu salinan fotostat.
13. Pasport : asal serta satu salinan fotostat.

1. Completed Form 4 under the Dental Regulations 1976 – Registration Form.
2. Basic dental qualification: original and one photostat copy.
3. Photographs: three (3) copies of a latest coloured passport sized photograph.
(*Instamatic photographs are not acceptable; ensure suitable dressing*)
4. Registration fee: to the amount of RM 150.00 (Ringgit one hundred and fifty only) in the form of a bank draft, money order or postal order made out to the **“Pendaftar Majlis Pergigian Malaysia”**. Cash and personal cheques are not accepted.
5. National Registration Identification Card: original and one photostat copy
6. Birth certificate: original and one photostat copy.
7. Taiwan National Licensing Board Examination Certificate: original and one photostat copy.
8. Evidence of two (2) years clinical experience after graduation.
9. Transcript of Grades for 5 years
10. Form 5 under the Dental Regulations 1976 – Certificate Of Satisfactory Public Service In a Dental Capacity.
11. National Registration Identification Card of husband/wife: original and one photostat copy.
12. Marriage Certificate: original and one photostat copy.
13. Passport: original and one photostat copy
